

## Threats to MA dictionary publisher land man a year in prison

A California man who made violent anti-LGBTQ-related threats against dictionary publisher Merriam-Webster Inc. over its updated gender definitions was sentenced Thursday to a year in prison.

The sentence imposed on Jeremy Hanson, 35, by a federal court in Massachusetts also included 30 days of home confinement, three years of probation and mental health treatment.

Hanson pleaded guilty last year to

interstate transmission of threatening communications in connection with threats made to the Springfield, Massachusetts-based dictionary publisher and to the president of the University of North Texas.

In court documents, prosecutors said the Rossmoor, California, man has a history of making "threatening communications, nearly all of which were motivated by ... biases based upon race, gender, gender identity, and/or sexual orientation."

Those other communications were

## Man Threatens to Shoot and Burn Hingham Pride Flag

A man threatened to shoot down and burn a Pride flag that was displayed at the Derby Street Shoppes in Hingham. Hingham police identified the man as Gage Scammell, and say he left a voice-mail to the mall management on April 13, demanding that they take down the flag within three days or he would shoot down the flag with a rifle and burn it. He also expressed his hatred towards Jewish people in his message.

Scammell, was charged with interference with civil rights, threatened use or presence of deadly weapons, and threat to commit a crime. He appeared in court on April 17 and was arraigned in Hingham District Court on the following charges: interference with civil

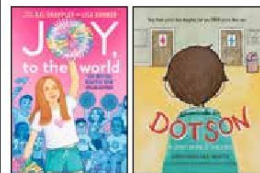

In this time of unconscionable attacks on transgender youth, two new middle-grade books, one by a trans girl and one by a trans boy, are both timely and vital.

"Joy to the World," by Kai Shappley and Lisa Bunker (Clarion), is a fictional

story heavily shaped by Kai's real life as a transgender girl and activist growing up in Texas. The protagonist, 12-year-old Joy, has just moved to Texas with her divorced mother. Her family supports her

## Counter Protesters Heavily Outnumber Those Rallying for Cancellation of Newton Drag Show

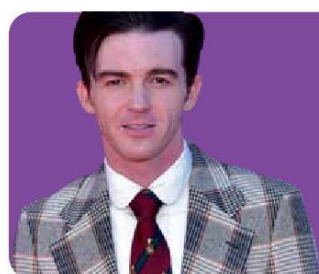

# Wisconsin Sen. Tammy Baldwin launches run for 3rd term

MADISON, Wis. (AP) - Democratic U.S. Sen. Tammy Baldwin, who spearheaded legislation to protect same-sex and interracial marriages last year, announced on Wednesday that she is seeking a third term in battleground Wisconsin.

Baldwin, 60, said in a statement that she intends to continue fighting for the working class and families struggling with inflation, as well as opposing Wisconsin's abortion ban.

No Republicans have announced they are running for Baldwin's seat, which will be critical for Democrats to hold if they want to maintain control of the Senate.

Baldwin won her first local race at age 24 and

in 1998 won a seat in the U.S. House to become the first woman whom Wisconsin voters sent to Congress. She was elected to the Senate in 2012, handing former Republican Gov. Tommy Thompson his first defeat in a statewide race, in a year when Barack Obama was also on the ballot.

Baldwin will be seeking a third term in a presidential election year when turnout on both sides is likely to be high.

Baldwin won her 2012 race by nearly 6 percentage points and defeated a Republican state senator for reelection in 2018 by 11 percentage points. In that race, which came two years after Donald Trump won Wisconsin, Baldwin solidified Democratic support while attracting independent voters with her message that she was looking out for the best interests of everyone in the state.

A tireless campaigner, her victory in the swing state was closely analyzed and followed by Democratic candidates who also found success, including Gov. Tony Evers, who won reelection in 2022. Her strategy included highly targeted digital ads on a variety of issues and competing for voters outside of the Democratic strongholds in Madison and Milwaukee.

Baldwin was the first person elected to Congress after announcing they were gay and was the first openly gay person elected to the Senate. In the early 1990s, she was the first openly lesbian member of the Wisconsin Assembly and one of the first openly gay people in elected office across the country.

She has been open about her sexual orientation but did not emphasize it during her previous runs for the Senate.

"I didn't run to make history," Baldwin said after winning her first Senate race in 2012. "I ran to make a difference."

But in 2022, after the U.S. Supreme Court struck down the Roe v. Wade ruling that legalized abortion, Baldwin gained national attention for her leading role in passing a bill protecting the rights of gay couples. She spent months winning over Republicans for the measure, which passed last December with bipartisan support.

Republicans have tried to portray Baldwin as too liberal for Wisconsin, a state that reelected Republican Sen. Ron Johnson in 2022 and that Trump narrowly won in 2016 and lost by a similarly small margin in 2020. Johnson is one of the Senate's most conservative members.

But Baldwin, despite embracing policies like "Medicare for All," has been able to win over key swing voters in the state.

# Norm Kent: A Pioneer of LGBT and Marijuana Activism

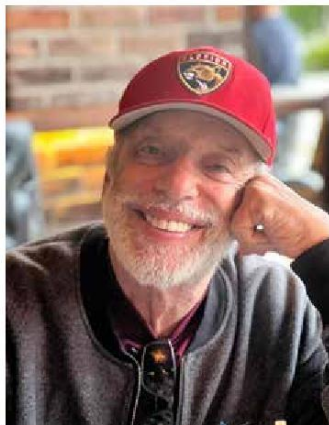

Norm Kent was an attorney, publisher, radio host, and a trailblazer for LGBT and marijuana rights, a champion of social justice and a mentor to many, passed away in Florida on April 13, 2023, after a long battle with pancreatic cancer.

Kent was one of the founding members of NORML, the National Organization for the Reform of Marijuana Laws, and served as its national board chairman. He fought for the legalization of cannabis and the end of the war on drugs. As a lawyer, he defended countless clients who faced discrimination, harassment and criminalization because of their sexual orientation or gender identity.

Kent founded the Express Gay News in 1999, which later became the South Florida Blade.

In January 2010, Kent launched a new newspaper and website called South Florida Gay News, along with a new business partner Piero Guidugli, who stayed with the company until 2020.

## 'No Justins, no peace!'

Fighting old battles with new fervor

In 2002, two transgender teenagers named Ukea Davis and Stephanie Thomas were shot to death one night in Southeast DC. The Washington Post identified them by their birth names, not their chosen names. In the aftermath, I attended a meeting in the basement of a church on East Capitol Street. Many issues were discussed, from public safety to development.

Also attending the meeting was a savvy older black woman who served on the advisory neighborhood commission. Afterward, she paused to look at a framed picture of Dr. King on the wall. Standing beside her, I said, "Look at that handsome man." She said, "Oh, yes, he was very good looking." I then realized she had been a young woman in King's heyday.

Thus we connected despite being separated by more than the 70 blocks between our homes. Our differences of race, gender, and orientation were bridged by a tragedy. On the evening after the shootings, I and other activists had stood at the crime scene across from Nalle Elementary with the mayor, police chief, reporters, and neighborhood residents. A toddler standing near me held a soccer ball almost as large as himself. He started wandering toward a boarded-up apartment building before his mother stopped him.

That child, blissfully unaware of the particular darkness that brought us together, is by now just a few years younger than the two Tennessee Justins, who are about the age King was during the Montgomery bus boycott. Members

of Gen Z, they grew up with greater expectations for LGBTQ people than their parents did. At the same time, the MAGA backlash threatens to turn back the clock and run our democracy into a ditch.

DC Emancipation Day is April 16, marking the day in 1862 when slavery was abolished in the District of Columbia. In 2023, there are still people in need of emancipation from racial, gender-based, and other forms of intolerance.

Missouri Republicans recently voted to defund all public libraries. That is like putting a loaded gun to your own head and saying, "Vote for me or the idiot gets it."

Luckily, teens denied access to books on black or LGBTQ themes can access them electronically through Brooklyn Public Library's Books Unbanned initiative.

Regarding the Tennessee legislature, Radley Balko writes on Substack: "Fresh off mandating that professors teach 'both sides' of slavery ... our idiot legislature is now encouraging students to snitch on teachers who are too 'divisive,' and in a particularly Orwellian twist, claiming this is all in the name of 'promoting free expression.'"

Teaching children a non-airbrushed version of our history is essential to bringing the "liberty and justice for all" promised in the Pledge of Allegiance yet denied by Tennessee House Speaker Cameron Sexton and his confederates.

It was not until 2021 that a bust of Confederate general and early Ku Klux Klan leader Nathan Bedford Forrest was removed from the Tennessee state capitol. He led a

massacre at Fort Pillow on April 12, 1864, in which 300 Union soldiers, most of them black, were gunned down after surrendering.

A leaked audio of Tennessee Republicans includes Rep. Jason Zachary objecting to being called racist. If they allowed non-white voters to have their representatives heard in the legislature and desisted from celebrating a racist heritage, it would signal their readiness to help build a new South. Instead, they continue to re-litigate the Civil War.

Michael Harriot of The Grio notes that a majority of Tennesseans support universal background checks, red flag laws, Medicaid expansion, and abortion rights. Their Republican representatives do not care.

Rep. Justin Pearson's former writing and rhetoric teacher at Bowdoin College, Meredith McCarroll, writes in Salon about him and the other members of the Tennessee Three: "Their voices are disruptive not because they know of no other way to speak, but because the situation called for disruption."

Republicans provided a reminder of the continuing threat by targeting the Tennessee Three with a robocall falsely accusing them of being violent radicals. It is truly depraved for politicians who defend the January 6 insurrectionists at the US Capitol to demonize peaceful protesters for gun safety in Nashville.

Pearson knows that he and his fellow change agents cannot succeed simply by sitting politely in the legislature while a corrupt Speaker stands smirking with his finger poised on the mute button. The continuing demands by the diverse young people who protested outside the chamber and beyond are charting the course and providing the fuel to make our country live up to its creed.

# Over Half of Trans = Youth Ages Could Face Barriers to Life-Saving, Medically Necessary Gender Affirming Care

New HRC Data

Washington, D.C. — On March 22, the Human Rights Campaign (HRC), the nation's largest lesbian, gay, bisexual, transgender and queer (LGBTQ+) civil rights organization, released data indicating that more than half (50.4%) of transgender youth (ages 13-17) have lost or are at risk of losing access to age appropriate, medically necessary gender-affirming care in their state - care which is, in many cases, life-saving. The figure was pulled from the more than 300,000 transgender youth aged 13-17 in the U.S., as reported by the Williams Institute. This alarming finding, as bans on gender affirming care are on the verge of going into effect in more than 10 states, is highlighted in a newly launched map developed by HRC that tracks legislative and administrative attacks on gender affirming care. Gender

affirming care, when made in consultation between a provider, their patient, and the patient's parents, is backed by decades of research and is supported by every major medical association, representing over 1.3 million doctors nationwide.

However, amid growing disinformation peddled by extremists and national anti-LGBTQ+ organizations, lawmakers in statehouses across the country continue to introduce and pass legislation that severely restricts or prohibits gender affirming care for transgender youth. Additionally, Florida and Texas have prohibited this care through administrative action. Politicians invoke counterfactual concerns about the best interests of transgender youth, but some states, such as Oklahoma, South Carolina, and Texas are even considering legislation that would ban care for transgender people up to 26 years of age. Indeed, the national anti-LGBTQ+ groups pushing for these bills have admitted that their

goal is to ban gender affirming care for all transgender people.

To date:

Seven states have enacted laws banning gender affirming care (AL, AZ, AR, MS, SD, TN, UT)

Four states have passed legislation banning gender affirming care that is currently awaiting signature or veto from their governor (LA, GA, KY, WV)

Six states have advanced gender affirming care ban legislation through one chamber (ID, IN, KS, MT, ND, and OK)

In addition, Florida's Board of Medicine forbade gender affirming care last year via administrative action, which took effect March 16, 2023, and the Governor of Texas last year directed the Texas Department of Family and Protective Services to investigate the provision or support of gender affirming care by parents, doctors, or others, as child abuse.

rights, threatened use or presence of deadly weapons and threat to commit a crime.

"The Hingham Police Department supports and stand with our LGBTQ+ and Jewish communities and we will not tolerate any threats or discrimination against them,"

Hingham police Chief David Jones said in a statement.

The Pride flag was part of a display that celebrated diversity and inclusion at the Derby Street Shoppes mall.

The incident sparked outrage and solidarity among the local residents and activists, who organized a rally on April 16 to show their support for the Pride flag and the Jewish community. They also denounced Scammell's threat and called for more tolerance and acceptance in society.

The rally was attended by hundreds of people, including local officials, religious leaders, and representatives of various organizations. They held signs that read "Love Wins", "Hate Has No Home Here", and "We Stand With You". They also sang songs and chanted slogans of unity and peace.

identity, and she's beginning to make friends and practice her newfound love of cheerleading with her "Sparkle Squad." When her school principal says she can't be on the school cheerleading team because she's not a girl, however, she decides to challenge him, and later to speak out against anti-trans legislation in the state, inspired by her hero, Kai Shappley, who has done the same. In fact, she even ends up meeting Kai and her mother, who help Joy and her family in their fight.

Joy is "just a kid" whose life (like Kai's) is full of friends and fun and bolstered by her Christian faith, and whose only exposure to "perversion" and "indoctrination" is when those words (which she must look up to understand) are used by those speaking against her.

Joy's mother, though supportive, wants to protect her daughter from the inevitable hateful comments that Joy's activism will trigger online and in the media. As Joy and her mother navigate this together (as I imagine Kai and her mom have, too), they provide a model for readers and their families who may be going through something similar.

Details from Kai's real life are woven into the tale—but a fictional protagonist gives the narrative a greater flexibility. Kai's appearance in the story as herself, however, reminds us of the tale's real-life roots, and her interaction with Joy and her family underscores how real trans youth and their families are building networks of information and support. And co-author Lisa Bunker, both a published novelist and one of the first two trans women to serve in the New Hampshire legislature, has clearly brought to bear her writing skills, her knowledge of the trans community, and her knowledge of state legislative processes.

Kai and her family left Texas in 2022 because of the state's increasingly harsh anti-trans laws, but her deep familiarity with life there for trans youth makes this a resonant, empowering book that trans youth in anti-trans states may particularly appreciate. The book's storyline of a determined young person fighting for her rights with the help of her family and friends, however, should have an even wider appeal.

"Dotson: My Journey Growing Up Transgender," is a memoir more directly following the life of its young author, Grayson Lee White. When Grayson was two years old, he asked his mother, "Why did God make me a girl?" insisting, "I am supposed to be a boy." The book takes us with engaging candor on his journey from then to the present.

As a preschooler, he started calling himself "Dotson," a combination of "daughter" and "son." That name stuck until he and his family learned the correct term, "transgender." With his parents' support, he chose a new name and began using he/him pronouns. He came out to his class (with support from his identical twin sister), ran into obstacles over which bathroom to use, legally changed his name, and began seeing an endocrinologist at age seven—not to start puberty blockers, but to begin the careful preliminary monitoring that could someday lead to that. This depiction of the lengthy process is important because of the many accusations from proponents of anti-trans legislation that such gender-affirming care is initiated too quickly.

As Grayson got older, he also came out to new friends (with varied reactions) and started having to deal with sometimes intrusive questions. At age 12, he got his first puberty blocking shot (which he was excited about despite his fear of needles). The story ends (for now) with him at age 13, thriving and happy, a young man who plays video games, rides his bike, and snowboards, though he admits to sometimes being socially awkward. He is careful to convey that not every trans person has an identical experience.

Although his supportive family and friends have clearly made his journey easier, he's also upfront about the questions, concerns, and worries he's had—and some he still has. Still, he says, all the challenges have been worth it in order to be himself.

"Dotson," with short chapters illustrated by Stephanie Roth Sisson, feels like the perfect next book for kids who have moved beyond picture books, though older middle-grade readers should enjoy it as well. While it came out last year in a version exclusive to Target, it is being rereleased for wider distribution by West Margin Press. Through a trans youth's own words, it shows how trans youth can thrive when they have support and affirmation.

Both books above will likely face bans—and are already blocked by the "Don't Say Gay or Trans" laws in eight states—but now you know they exist. Recommend or buy them for anyone you know who may appreciate them—trans youth, their families, allies, and those who could become allies. And perhaps someone will airdrop copies of them at the state houses of every legislature considering anti-trans bills. These are voices that need to be heard.

directed at the American Civil Liberties Union, Amnesty International, Land O' Lakes Inc., Hasbro, a nonbinary rabbi and others, prosecutors said.

In a remote hearing Thursday, prosecutor Steven Breslow asked for an 18-month prison sentence, in part to serve as a deterrent to others at a time when violent rhetoric is becoming more common.

Hanson's defense attorney, Marissa Elkins, asked that her client be sentenced to the time he has already served, citing his history of emotional and behavioral issues, including anxiety and obsessive-compulsive disorder.

More time behind bars could negatively affect his mental health, she said.

Judge Mark Mastroianni in U.S. District Court in Springfield acknowledged Hanson's medical history and said he had no intent or capacity to carry out his threats, but called his actions "disturbing and terrifying."

He noted that Merriam-Webster management was "fearful that Hanson would come to their office and cause harm," and said internal company communications referenced the

2015 attack on Charlie Hebdo offices in France, where terrorists killed 12 people who worked for the satirical weekly newspaper.

Hanson sent Merriam-Webster threatening messages and comments between Oct. 2 and Oct. 8, 2021 using the website's "contact us" function, where he commented on word entries such as "girl," "woman," and "female," prosecutors said.

"It is absolutely sickening that Merriam-Webster now tells blatant lies and promotes anti-science propaganda," Hanson wrote, according to prosecutors. "There is no such thing as 'gender identity.' The imbecile who wrote this entry should be hunted down and shot."

Twice he threatened to shoot and bomb company headquarters, prompting Merriam-Webster to close offices in Springfield and New York City for several days, prosecutors said.

Hanson also wrote an email to the president of the University of North Texas in 2022 that said "You ought to be shot in the head and have your offices set on fire," for supporting transgender students, prosecutors said.

Hanson, who appeared at the hearing remotely from a California jail, declined to address the court when given the opportunity.

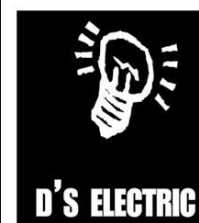
