U.S. Supreme Court LGBTQ+ Book Case Is About More Than Just Books

The U.S. Supreme Court will hear a case on April 22 about whether parents have the right to opt out their children before LGBTQ+-inclusive books are read in public school classrooms. It's about more than just books, however, as newly filed amicus briefs show.

The case began when Montgomery County Public Schools (MCPS) in Maryland added several LGBTQ+-inclusive picture books to its supplemental curriculum in 2022. The books had been evaluated by a committee of staff members through the district's usual process and were in-

tended as optional titles for teachers to recommend or read to students if desired.

A group of parents, however, brought a lawsuit in 2023 against MCPS, claiming that the school

CONCORD, N.H. (AP) — Four-term Congressman Chris Pappas of New Hampshire announced his bid Thursday to succeed retiring U.S. Sen. Jeanne Shaheen, a fellow Democrat,

In Scotus Brief, AG Campbell Defends Use Of LGBTQ+-Inclusive Books In Public Schools

BOSTON — Massachusetts Attorney General Andrea Joy Campbell has co-lead a coalition of 19 attorneys general in filing an amicus brief in the Supreme Court of the United States to defend the discretion of public schools in Montgomery County,

Maryland, to incorporate LGBTQ+-inclusive books into their curricula without offering parents an opt-out option.

The brief was filed in support of the respondents in *Mahmoud, et al. v. Taylor, et al.* and argues that the use of curricula with LGBTQ+-inclusive

amous people like Rachel Maddow are not being purged; but at any moment, any of us could become desaparecido at the whim of Trump's zealots.

violated their religious freedom by not giving them the chance to opt out their children from classroom readings of the books. The specific titles they named as objectionable were the picture books “Born Ready: The True Story of a Boy Named Penelope”; “IntersectionAllies: We Make Room for All”; “Prince & Knight”; “Uncle Bobby’s Wedding”; “Love, Violet”; “My Rainbow”; “Pride Puppy”; “Jacob’s Room to Choose”; and “What Are Your Words?”

After a federal district court and appeals court both denied the plaintiffs a preliminary injunction that would have required the district to temporarily grant the parents’ request, the parents asked the Supreme Court to take the case, *Mahmoud v. Taylor*, which it did.

We’ve seen a similar case before. In 2008, four parents claimed that the Lexington, Mass., public school district violated their constitutional rights by putting LGBTQ+-inclusive picture books in its elementary school curriculum. In that case, *Parker v. Hurley*, the 1st Circuit Court of Appeals in a unanimous ruling wrote, “There is no free exercise [of religion] right to be free from any reference in public elementary schools to the existence of families in which the parents are of different gender combinations.” The Supreme Court refused to hear the case.

In *Mahmoud*, amicus briefs in defense of MCPS were filed in early April by most of the major LGBTQ+ organizations, along with numerous civil rights, educational, publishing, and faith organizations, plus a bevy of legal scholars, 19 attorneys general, and more. Here are a few of their arguments, showing some of the case’s many ramifications.

A brief from GLBTQ Legal Advocates and Defenders, the National Center for Lesbian Rights, the Human Rights Campaign, Family Equality, COLAGE, FreeState Justice, GLSEN, and The Trevor Project explains that the books help develop students’ English language skills, but also “foster skills of civility and respect that are needed in a functioning school system and a healthy democracy.” Conversely, LGBTQ+-only opt-outs “[send] a troubling message to students that some families are less worthy of acknowledgment and respect than others.” Creating an opt-out system, too, “would impose an unworkable administrative burden on schools and undermine educators’ ability to focus on their core teaching responsibilities.”

PEN America, in its brief, adds that an opt-out scheme “would impose a significant burden on those who want to read and discuss LGBTQ+-inclusive books—a burden not imposed on those who want to read and discuss books about straight and cisgender people,”

meaning that “the injunction that Petitioners seek is a constitutionally suspect book ban by another name.”

A brief from the Authors Guild, the Educational Book & Media Association, and Penguin Random House asserts that the plaintiffs “fail to recognize that merely exposing students to books that depict a range of family relationships and identities, including some that might fall outside the boundaries of some religious orthodoxies, does not rise to the level of indoctrination.”

And a brief from the American Civil Liberties Union and the ACLU of Maryland elaborates that allowing religious exemptions from classroom material is a slippery slope. Parents could then object to Shakespeare’s “Twelfth Night” “because a woman character pretends to be a man,” or “Lessons in patriotism could be viewed by some people of faith as improperly elevating country over God.” Additionally, “Others might object to their children being in the classroom for a peer’s presentation on their family tree, if the family tree includes same-sex parents.”

That last argument is key. It’s a very small step between restricting books and restricting what children say about themselves and their families. And it is easy to see the case as part of a wider effort to erase LGBTQ+ identities, as exemplified in the recent presidential executive order declaring there are only two genders and the efforts to remove mentions of LGBTQ+ and other marginalized people from federal websites.

Eighteen of the authors and illustrators whose books are cited by the plaintiffs issued a statement in February, saying in part, “Children need to know that there are other people like them in the world, that they aren’t alone, that their hopes and fears are shared by others. And they need the freedom to read about different people with different views.” This “helps prepare them to be good citizens, to navigate and succeed in a complex and diverse world.”

“We have been told about children hugging our books and carrying them everywhere they go,” they shared.

These books matter because the children who see themselves and their world in them matter. Organizers of a Rally for Inclusive Education, to be held outside the court building on the day of the hearing, say on their website that the case is “about the soul of public education in the United States.” That’s true—but I’d add that it’s also about the souls and selves of our country’s children.

Choice Award for fostering environments that support development, encourage dreams, and foster belonging and inclusion. The Lancaster-based organization holds an annual drive to collect toiletries, snacks, and school supplies for youth served by Safe Homes.

Jason Homer (he/him) of Marlborough, received the Public Service Award for championing the vital role of libraries nationwide in education, inclusion and community growth, and ensuring they remain essential spaces for learning for all individuals. He is the Executive Director of the Worcester Public Library, leading its seven branches and advocating for community-focused services. Homer is also President of the Worcester Cultural Coalition.

The Woo Bar & Grill was honored with the Small Business Award for creating a safe and welcoming environment for all individuals at its Worcester-based establishment. Owners Jon Pittsley (he/him) and Eddie Rocco (he/him) opened The Woo Bar & Grill in 2023 and have over 30 years of combined experience in the restaurant industry. Pittsley and Rocco also provide support to myriad local nonprofit organizations.

Shane Franzen (he/him) of Fitchburg, received the Safe Homes Partnership Award for his support of LGBTQIA+ youth at Fitchburg State University and advocacy of Safe Homes North on the campus. books without an opt-out option falls within public schools' longstanding authority to foster safe learning environments and does not violate anyone's right to freely exercise their religious beliefs.

Although the case specifically focuses on policies of the Montgomery County Board of Education, the Supreme Court's decision in the case could be consequential for public schools nationwide.

"Preparing our children to engage with and thrive in a diverse society is a central premise of education. Local school districts have the right to determine that the use of LGBTQ-inclusive books helps to foster inclusive learning environments for all our students," said AG Campbell. "I am proud to stand in defense of inclusive books, which teach our students to respect one another, regardless of, and without interfering with, their respective personal beliefs."

In March 2023, the Montgomery County Board of Education (Montgomery County) in Maryland adopted a mandatory K-5 language arts curriculum that included LGBTQ-inclusive books and was designed to foster respect and tolerance for LGBTQ+ individuals. The petitioners filed a lawsuit and motion for preliminary

injunction challenging the policy, arguing that the lack of an opt-out option violated their First Amendment right to freely exercise their religious beliefs. They claimed a right to object to – and opt their children out of – the teaching of tolerance on religious grounds. In 2024, the U.S. Court of Appeals for the Fourth Circuit affirmed a lower court's decision to deny the preliminary injunction, finding that the challenge concerned the mere exposure of petitioners' children to LGBTQ-inclusive books through Montgomery County's curriculum, which did not interfere with the petitioners' free exercise rights. The Supreme Court is slated to hear arguments on the petitioners' challenge on April 22.

In filing the brief, the coalition urges the Supreme Court to reject the petitioners' challenge because Montgomery County's policies do not violate the Constitution.

Montgomery County's Policies Fall Within State and Local Governments' Authority to Shape Public Education and Create Safe and Inclusive Environments for Students

The coalition argues that Montgomery County's use of LGBTQ-inclusive books is an effort to foster a safe and inclusive environment for students and protect LGBTQ+ students from harm. The coalition further asserts that this effort falls well-within the long-held and broad legal authority of state and local governments to shape public education and design educational

environments that support the success of all students.

The coalition references research indicating that LGBTQ+ students experience disproportionate levels of harm from discrimination and bullying in schools. A 2022 study found that 68% of LGBTQ+ students reported feeling unsafe at school due to their sexual orientation or gender identity and that nearly all of LGBTQ+ students reported hearing homophobic language by peers.

The coalition also references research indicating that students with access to LGBTQ+ supportive school environments, including curriculum with LGBTQ-related topics, have experienced less discrimination, better psychological wellbeing, and a greater sense of belonging at school. As such, Montgomery County's policies are also aligned with state laws designed to address discrimination and bullying in schools and create inclusive learning environments for all students.

While the petitioners argue they should be able to opt-out of the LGBTQ-inclusive curriculum because they are allowed to opt-out of sex-education classes, the coalition asserts that the LGBTQ-inclusive books in question are not related to sex-education, but are rather designed to foster greater inclusivity and safety for LGBTQ+ individuals. By not allowing an opt-out option, Montgomery County affirms

its commitment to inclusivity by teaching all students to treat LGBTQ+ individuals with dignity and respect, regardless of one's personal beliefs.

Mere Exposure To LGBTQ-Inclusive Books Does Not Burden the Right to Free Exercise of Religion

The coalition asserts that, in accordance with the Fourth Circuit's findings, the only constitutional question presented at this preliminary stage of the case is whether the mere exposure of students to LGBTQ-inclusive books in schools violates their parents' right to freely exercise their religion. Because such exposure to contrary views through LGBTQ-inclusive books does not force or compel the petitioners to abandon or act against their religious beliefs, the coalition argues that — consistent with Supreme Court precedent — no constitutional violation has occurred in relation to Montgomery County's policy.

Joining AG Campbell in co-leading the amicus brief is Maryland Attorney General Anthony Brown. The amicus brief was also joined by the attorneys general of California, Connecticut, Colorado, Delaware, the District of Columbia, Hawaii, Illinois, Maine, Michigan, Minnesota, Nevada, New Jersey, New York, Oregon, Rhode Island, Vermont, and Washington.

Détente. That was the word **Patti LuPone** used when she reunited with **Lord Andrew Lloyd Webber** at the 2018 Grammys. Maybe it's something about New York City, because another notable détente just took place there—this one between **Sir Elton John** and **Madonna**. First, a bit of history. The twosome has traded barbs as far back as 2004, when Elton made an acceptance speech at the Q Awards and dogged Madge's nomination. "Madonna? Best fucking live act? Fuck off. Since when has lip-syncing been live?" And that was him being nice!! An amusing exchange took place at the 2012 Golden Globes. Each had a song nominated in the same category. Last year, Elton John revealed some staggering statistics about the Elton John AIDS Foundation. "Since our founding in 1992, we have saved over 5 million lives and raised more than \$600 million to support over 3100 projects in 95 countries globally to end AIDS." One of those countries will no longer be Russia. The Russian general prosecutor has called the nonprofit "undesirable" and accused it of attempting to undermine Russian "spiritual and moral values with propaganda." The organization was quick to respond: "In 2024, there were over 1.2 million people living with HIV in Russia, with over 430,000 not receiving treatment. Today's decision...will undoubtedly endanger lives and disrupt critical HIV prevention efforts."

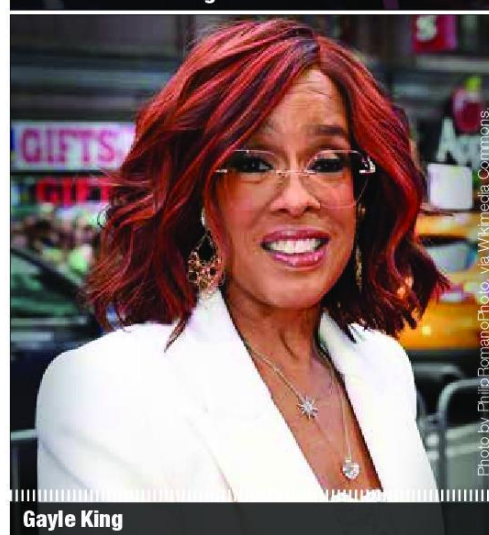

values of this state," Pappas said in a video announcement.

He added: "Like Senator Shaheen, I'll always put New Hampshire first. You can count on me to lead the charge to confront this administration, self-dealing billionaires, and extreme politicians who threaten our future and our ability to get things done for New Hampshire."

Pappas, 44, emerged as the most likely Democrat to succeed Shaheen, who turned 78 in January. She was the first woman elected to serve as both governor and senator in the United States. Shaheen, serving her third term in the Senate, announced in March that she would not seek reelection.

Pappas could potentially face a formidable Republican opponent. Former New Hampshire Gov. Chris Sununu is considering a run. The popular governor decided not to seek a fifth, two-year term last year.

Last year, Pappas defeated Republican former state Sen. Russell Prescott to win New Hampshire's 1st District, which covers the eastern half of the state and includes its largest city, Manchester. Pappas is from there. The district was once quite politically volatile, with party control flipping five times in six election cycles from 2006 to 2016.

Pappas, who considers himself a pragmatic voice in Washington, touted his support from women, veterans and the U.S. Chamber of Commerce during the campaign. He made abortion rights a top issue, calling Prescott "radically out of step" and accusing him of distrusting women to make health care decisions.

In 2022, Pappas defeated Republican candidate Karoline Leavitt, now White House press secretary. During that race, Leavitt said she believed the 2020 election was stolen from President Donald Trump. Pappas said she "continues to double-down on the big lie."

He made history in 2018 by becoming the state's first openly gay member of Congress.

Pappas has helped run his family's restaurant in Manchester and was part of a state council that approves spending contracts.



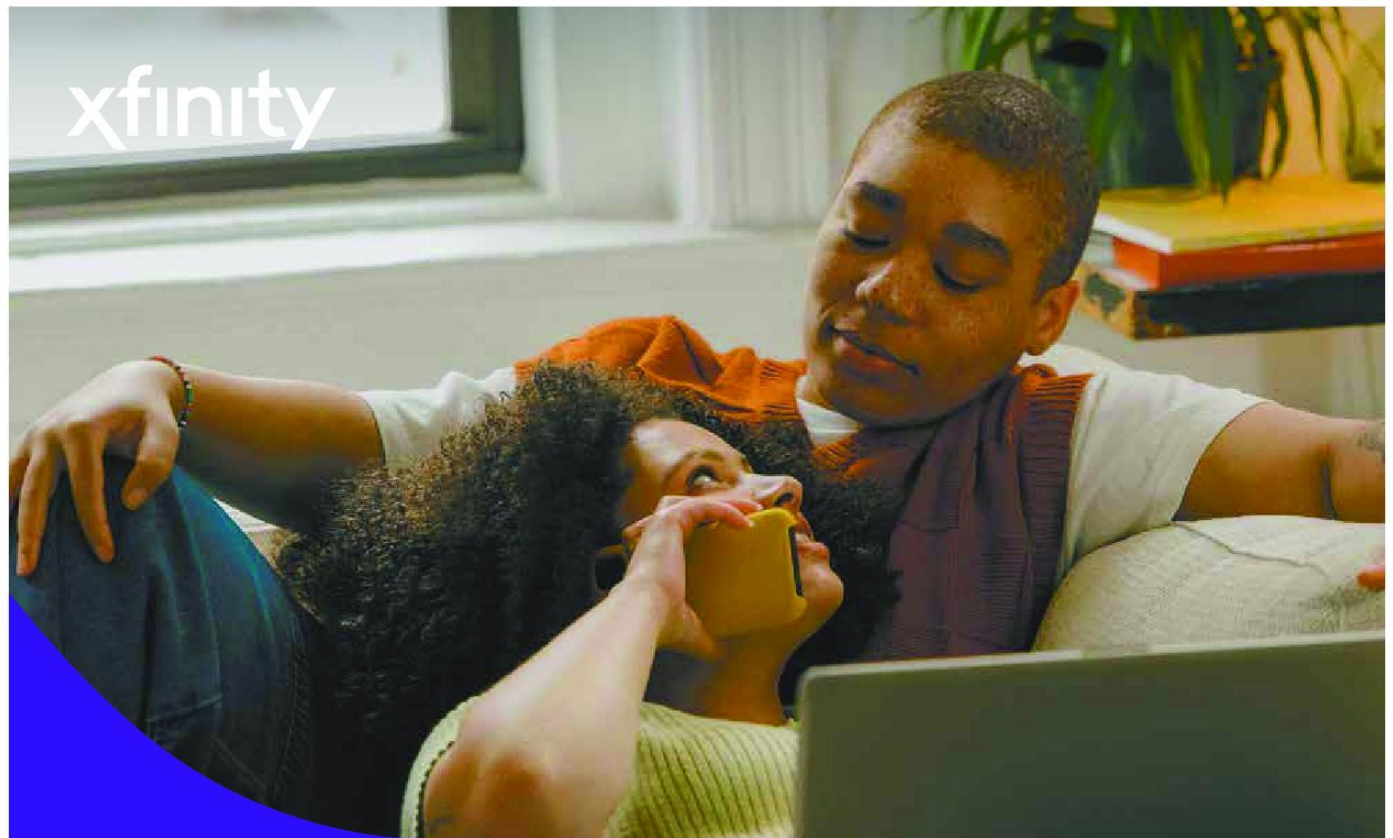
