The Battle to Protect IVF

I started my family more than two decades ago via in vitro fertilization (IVF), and I've watched with growing alarm as the U.S. Supreme Court's Dobbs decision that overturned federal abortion rights two years ago has also endangered access to this common fertility technique. Jennifer Klein, director of the White House Gender Policy Council, spoke with me about the threat and the Biden administration's response.

The risk to IVF became clear this year when the Alabama Supreme Court ruled on February 16 that frozen embryos should be considered

"children." Almost all IVF providers in the state immediately halted services, fearful of liability. State legislation was quickly passed to provide legal immunity to IVF providers and patients—but some lawmakers and advocates remain concerned that it still does not sufficiently address the state's constitutional definition of embryonic personhood, as CNN reported (3/7/2024).

The question of embryos also played into the June 12 vote by the Southern Baptist Convention, representing the country's largest Protestant denomina-

Senator Edward J. Markey (D-Mass.), a member of the Senate Health, Education, Labor, and Pensions (HELP) Committee, today introduced the Elder Pride Act, legislation to support LGBTQI+ older adults and older adults living with HIV. The legislation would establish

MA House Passes Parentage Act, Advancing Bill for Senate Approval

On June 12, the Massachusetts House of Representatives today voted unanimously to pass an act to ensure legal parentage equality, better known as the Massachusetts Parentage Act (H4672), historic legislation that will protect LGBTQ+ families, and children born through surrogacy and assisted reproduction, in forming the legal bond of a parent-child relationship. The bill now advances to the Massachusetts Senate.

"We are grateful that these long-overdue protections have passed the House and will now take this important step toward becoming law in Massachusetts," said Polly Crozier, Director of Family Advocacy at GLBTQ Legal Advocates & Defenders. "We are grate-

ful for Speaker Ron Mariano's leadership in advancing the MPA and for the many hours of work dedicated to this legislation by Chairman Michael Day through his leadership role on the Judiciary Committee. All families in Massachusetts, including many LGBTQ+ families, are one step closer to having the legal protections and security they deserve. As this bill advances, we look forward to working with the Senate - where we have strong bipartisan support - and the Senate President, who is also a longtime supporter of LGBTQ equality."

The MPA updates Massachusetts statutes to clarify who can be a parent and how to establish parentage. This bill is critical to ensuring that all children can access the security of legal parentage, regardless of the circumstances of

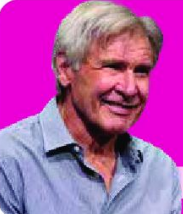

an Office of LGBTQI Inclusion within the Department of Health and Human Services (HHS) to advocate, coordinate activities, recommend policies for, and collect data on LGBTQI+ older adults.

The bill would also establish a rural grants program to serve the unique needs of rural LGBTQI+ older adults, including through education and training, community outreach and creation of community spaces, and improved cultural competency.

"After years of exclusion and discrimination from health care settings, workplaces, and their local communities, LGBTQ+ older Americans deserve the protections their neighbors are afforded," said Senator Markey. "Queer and trans elders should be able to age with dignity, grace, and surrounded by community. The Elder Pride Act will ensure that all older adults are able to have access to the care and services they need."

Cosponsors include Senators Bob Casey (D-Penn.), Ron Wyden (D-Ore.), Alex Padilla (D-Calif.), and Tammy Baldwin (D-Wis.).

"Older LGBTQ+ Americans have paved the way for equality their entire lives, persevering and fighting against discrimination and standing up against bigotry, regardless of the obstacles in their way," said Senator Bob Casey (D-Pa.), Chairman of the U.S. Senate Committee on Aging. "After a lifetime of fighting for equality, Congress has an obligation to ensure they are protected. The Elder Pride Act will establish an Office of LGBTQ+ inclusion in the Department of Health and Human Services to ensure that these brave Americans get the services and support they deserve."

LGBTQI+ elders have fewer sources of support compared to their cisgender and heterosexual peers, face higher poverty rates, and experience poorer health care outcomes and access. And the need to coordinate LGBTQI+ services and activities from HHS to local area agencies on aging (AAAs), designated agencies that serve older adults in cities and counties across the country, is only growing. The number of lesbian, gay, bisexual, transgender, queer, and intersex (LGBTQI+) older adults is estimated to increase to

7 million by 2030. Fewer than half of AAAs

report they would be able to offer or fund LGBTQI+-specific services.

Earlier this Congress, Representative Suzanne Bonamici (D-Ore.), Chair of the Congressional LGBTQI+ Equality Caucus' Aging Issues Task Force, introduced the

Elder Pride Act and the Ruthie and Connie LGBTQI+ Elder Americans Act, two House of Representatives bills which contain the provisions of Senator Markey's legislation.

Endorsements include: SAGE, Human Rights Campaign, National Center for Lesbian Rights, MAZON: a Jewish Response to Hunger, interACT, National Council on Aging, Gerontological Society of America, American Society on Aging, Justice in Aging, National Women's Law Center, National Association of Nutrition and Aging Services Programs, Grantmakers in Aging, Grantmakers in Health, Alzheimer's Foundation of America, LeadingAge, Whitman-Walker Institute, Fenway Health, New England Rural Health Association, Transhealth.

"NCOA applauds Sen. Markey for introducing the Elder Pride Act. We believe that every American deserves to age well, regardless of who they are or who they love. This legislation would make progress toward ensuring that LGBTQI+ older adults have equitable access to aging services through dedicated federal coordination and targeted grant programs, with a focus on rural populations. We know LGBTQI+ older adults and those living with HIV experience higher rates of social isolation and poverty, as well as barriers to health care. Now is the time to act, and we look forward to working in a bipartisan manner to advance the Elder Pride Act," said Ramsey Alvin, President and CEO, National Council on Aging.

"The Elder Pride Act would take vital steps in ensuring that LGBTQI+ older adults have the equitable and inclusive support they are afforded under the programs laid out in the Older Americans Act. Establishing an Office of LGBTQI+ Inclusion will address the unique challenges members of the community face through promoting aging services, offering grants, and in advocacy work. In addition, the rural outreach program will fill a large void in meeting the needs of people without access to reliable infrastructure," said James Appleby, BSPHarm, MPH, ScD (Hon), Chief Executive Officer of the Gerontological Society of America.

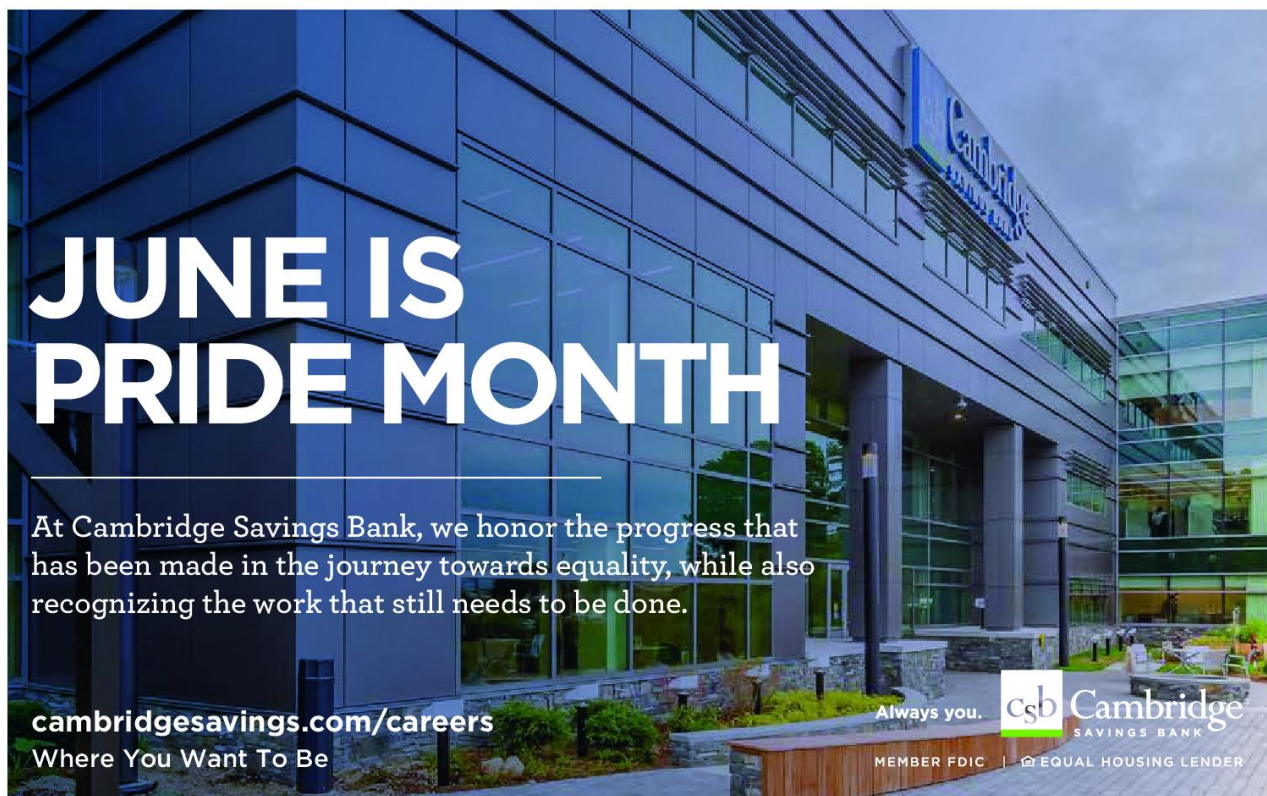

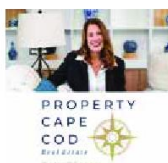

tion, to condemn the current practice of IVF because it may create excess embryos that are frozen or destroyed.

A whopping 86% of Americans believe that IVF should be legal, however, according to a CBS News/YouGov poll in early March. "These attacks on IVF are a direct result of Republican elected officials advancing a really extreme agenda, which is out of step with the vast majority of Americans," Klein said. "This is not a controversial issue, although it seems to have become one."

On February 29, Senator Tammy Duckworth (D-IL), an Iraq War veteran who used IVF to have her two daughters, sought Senate approval for a bill she had introduced with Senator Patty Murray (D-WA) to establish a federal statutory right to IVF and—critically—to an individual's use or disposition of their gametes and embryos.

Duckworth attempted to move the bill forward via unanimous consent, but Senator Cindy Hyde-Smith (R-MS) blocked it, asserting in a statement her "strong support of IVF," but expressing concern that the bill ran counter to "our goal to protect life and religious freedoms."

Senators Ted Cruz of Texas (R-TX) and Katie Britt (R-AL) then on June 12 attempted a unanimous consent vote on their own IVF Protection Act, which would have withheld Medicaid funds from states that prohibit IVF, but said nothing about the disposition of gametes/embryos. Klein explained that the bill "allowed restrictions on embryo storage, implantation and disposal, so it wouldn't actually provide meaningful access to fertility services." Murray therefore blocked it.

Democrats countered with the Right to IVF Act, intro-

duced in early June by Senators Duckworth, Murray, Cory Booker (D-NJ), Mark R. Warner (D-VA), and Tim Kaine (D-VA). This incorporated Duckworth and Murray's earlier IVF bill along with three other bills, which as a whole would create a federal right to IVF access and gamete/embryo disposition, lower costs by requiring insurers to cover IVF, and further expand IVF coverage options and access for veterans, service members, and federal employees. Senate Republicans, however, blocked that bill on June 13.

Klein observed that Republicans had also blocked a bill on June 5 that would have guaranteed a federal right to access contraception. She is adamant that "These attacks on reproductive freedom are a direct result of the overturning of Roe vs. Wade" and leaving matters of reproductive health to the states. Such attacks "stand in stark contrast with this administration," she said, noting that on the day of the Dobbs decision, President Biden committed to signing federal legislation to restore the protections of Roe vs. Wade as soon as a bill reaches him.

"In the meantime," Klein said, "we're doing everything we can to protect access to reproductive healthcare." This includes three executive orders and a presidential memorandum "to protect access and expand access to affordable, high-quality contraception, including over-the-counter birth control; strengthening privacy protections for patients and doctors; supporting and expanding access to medication abortion; supporting access to reproductive healthcare for service members and veterans; and supporting the ability to travel for reproductive healthcare."

The administration has also taken two actions specifically to protect IVF, she said. First, it "expanded eligibility for IVF services for certain service members and veterans," although the cause of infertility must still be a service-related health condition. Statutory restrictions mean that

further expansion must be through legislation, one of the things the Right to IVF Act would have provided.

Second, the administration "expanded access to IVF benefits and coverage for federal workers," something she hopes can also serve as "a model for other large employers across the country, because one of the major issues with IVF is affordability and insurance coverage." She noted that a majority of states (29) don't require private insurance to cover any fertility services.

While any administration is limited in what it can do in the absence of Congressional legislation, Klein said that "We are working really closely with Democrats on the Hill to support their efforts."

"I remain optimistic that [IVF] is a bipartisan issue," she asserted. Citing a March 2024 Navigator Research study, she explained, "Four in five Americans say IVF should be legal, the vast majority of Americans believe that Roe vs. Wade should not have been overturned and support reproductive freedom, and we've seen that in ballot initiatives across the country in a very diverse set of states," including Kansas, Michigan, Missouri, California, and New York. "When people have the opportunity to make their voices heard directly, they are quite clear that they want the ability to protect access to reproductive healthcare."

She urged people to continue sharing their views, adding, "As we've seen from unlikely people in unlikely states, people are speaking out to make it clear that they want the right to make decisions about their own body free from politicians. There are many more opportunities to do that."

their birth, including through assisted reproduction and surrogacy.

Currently, Massachusetts is the only state in New England without established statutory protections on parentage.

"What we are doing today is giving a tune up to our statutory structure to reflect the modern and contemporary ways that people become parents whether they are straight or gay," said Rep. Sarah Peake during her floor speech Wednesday. "This is a bill that is good for everyone in the Commonwealth of Massachusetts."

"At the heart of this bipartisan legislation lies a simple

yet profound principle: the recognition of legal parentage should not be contingent upon outdated norms or narrow definitions," said Rep. Hannah Kane, a co-sponsor of the bill, during her floor speech Wednesday. "It is a principle that acknowledges the diverse tapestry of modern families and affirms their right to legal recognition and protection under the law."

"Today we seek to modernize laws that currently treat parents who, despite loving and providing for their children just as much as any other parent does, we treat them as second class because of how they became a parent," said Rep. Day during his floor speech Wednesday.

Governor Maura Healey and Attorney General Andrea Joy Campbell expressed their strong support, respectively, for the legislation in April following the enactment of a similar piece of legislation in Michigan.

"We've been proud to be a national leader and trailblazer when it comes to LGBTQ+ equality, but we've got some catching up to do," said Governor Healey. "Let's pass the Massachusetts Parentage Act to make sure every family has the legal protections they need and deserve."

"Our state parental laws have not kept pace with the diversity of modern-day families, and as other states take the necessary steps to protect families, provide stability for children and advance reproductive and LGBTQ+ rights, it is clear it is well past the time for us to act and pass the Massachusetts Parentage Act," said Attorney General Campbell.

The bill's bipartisan sponsors include Democrat Senator Julian Cyr, Republican Senator Bruce Tarr, Democrat Representative Sarah Peake, and Republican Representative Hannah Kane.
