Appeals courts are still blocking Biden's efforts to expand LGBTQ+ protections under Title IX

NEW ORLEANS (AP) — A federal appeals court in New Orleans has refused to pause a lower court order that blocks a Biden administration effort to enhance protections for LGBTQ+ students under the federal law known as Title IX.

At issue is an administration rule meant to expand the definition of sexual harassment at schools and colleges and add safeguards for victims. The new protections have been praised by civil rights advocates. Opponents say they undermine the spirit of Title IX, a 1972 law barring sex discrimination in education.

A federal judge in western Louisiana had blocked the rule, responding

It's Kamala time!

Kamala Harris's life as Vice President took a 180-turn in 24 hours from her stumping for Biden in Provincetown, an LGBTQ+ culture hub and haven, on Saturday, July 20, to becoming a potential presidential nominee on Sunday, July 21, when the news broke of Biden leaving the race.

Brian Rosenberg is on a very personal mission to help LGBTQ+ people build their families. When he was in his 20s and 30s, he said in an interview, "Gay men were not thinking about becoming parents because everyone who would have done it was dying, and many of us, like myself, have HIV, and so we weren't planning for it."

Now, Rosenberg and his husband, Ferd van Gameren, who live in the Boston area, are the fathers of three young teens and co-founders of Gays With Kids (gayswithkids.com), an online community and resource for gay and queer men parents and prospective parents, which will soon ex-

MMAA urges the Senate to remove anti-LGBTQ+ healthcare amendments from the NDAA

We are extremely disappointed that the Senate has included amendments that target service members and their families by limiting their access to medical care. Transgender service members have openly served this country honorably for nearly a decade. Eliminating service members' medical care dishonors their service and breaks the promise our nation made to care for and support those who courageously defend our freedoms.

The proposed NDAA prohibits essential medical treatments which undermine the established standards of care recommended by major medical associations, including the American Medical Association (AMA), the American Academy of Pediatrics (AAP), the Endocrine Society, and the World Medical Association (WMA). These organizations recognize that affirming medical care, including hormone therapy and puberty blockers, is crucial for the mental and physical health of transgender people.

The specifics of medical care should remain in the hands of medical professionals and their patients. Transgender service members and LGBTQ+ military dependents deserve unwavering access to affirming, safe, and inclusive health care. Transgender service members represent 1% of active-duty personnel with 15,500+ transgender people serving honorably. Creating a discriminatory ban on "sex change surgeries" opens many types of medically necessary surgery to a potential ban.

Military families already face unique challenges and denying LGBTQ+ children access to essential medical care only adds to their burdens. Furthermore, puberty blockers do not affect fertility, and when stopped, puberty resumes.

Many military families with LGBTQ+ children already struggle to access essential healthcare services due to statewide healthcare bans. By denying coverage for medically necessary inter-

ventions, legislators are stripping away the right of transgender youth to receive comprehensive and affirming healthcare. This legislative move will likely lead to increased rates of depression, anxiety, and suicide among transgender minors, as well as exacerbate feelings of isolation and rejection. Studies have consistently shown that access to gender-affirming care significantly improves the mental health outcomes of transgender youth, reducing the risk of severe psychological distress.

It is imperative that Congress supports all LGBTQ+ service members and dependents by ensuring they have access to the necessary healthcare services that promote their overall well-being. If service members and their families lose access to comprehensive medically necessary care, it will exacerbate the current readiness, retention, and recruitment issues in the armed forces. Already, military families with transgender youth are choosing to leave service rather than force their dependents to live without medically necessary care.

We urge lawmakers to remove these amendments from the NDAA and recognize the critical importance of gender-affirming care for transgender individuals. Protecting the health and rights of LGBTQ+ individuals, including young people, should be a priority. Denying necessary medical treatments is not only discriminatory but also poses a direct threat to the lives and futures of transgender people.

lawsuit. That has so far resulted in the law being blocked in Kentucky, Indiana, Ohio, Tennessee, Virginia and West Virginia.

Other states where federal judges have blocked the new rule while it is litigated include Alaska, Idaho, Kansas, Texas, Utah, and Wyoming.

Republicans argue the policy is a ruse to allow transgender girls to play on some sports teams. The Biden administration said the rule does not apply to athletics.

nominee for the head of the ticket, enthusiasm swelled. Both the Black Caucus and Asian American Caucus immediately endorsed Harris. Within 30 minutes of her announcement, One Silicon Valley, a software engineering consulting firm, raised more than \$1 million.

Also hours later, a national Zoom call from the D.C.-based Black women's organization "#WinWithBlackWomen" had over 40,000 sists in attendance. In three hours, these women raised over \$1 million to support Harris, which TV, personality Star Jones, the campaign chair, spearheaded.

"#WinWithBlackWomen" is a national intergenerational and intersectional sisterhood of black diasporic women who leverage talent, influence, and networks to support Black women.

The politics of being the first

When I heard the news of Harris running for president, I immediately thought about how my deceased Brooklyn Congresswoman Shirley Chisholm would be proud of this moment. Chisholm was the first African American woman to campaign for the presidential nomination in 1972 on the Democratic ticket. A woman of temerity and integrity, her slogan was "Unbought and Unbossed." Confronted with racist and sexist opposition, Chisholm lost the nomination. In 2024, similar concerns arise for Harris, too.

When news broke that Kamala was in the race for the White House, Black Twitter was abuzz with exuberance and trepidation. "Much of Black Twitter is on board with Kamala as a candidate, but unsure if America feels the same way," The Root reports.

"Okay, so now it's Kamala. Every white person who wanted him to drop out needs to figure out how to defend a Black woman in person and online for the first time in their lives. That's the job now. I'd like to see it, but I never have," Comedian and podcaster Akilah Hughes wrote on Twitter.

Prominent Democratic donor John Morgan of Florida emphatically stated he would not fundraise for Harris. "She would not be my first choice," Morgan quoted in The Hill. "The donors holding the 90 million can release those funds in the morning. It's all yours. You can keep my million. And good luck," he continued.

Striking the right balance with white Americans - Republican or Democrat is difficult in this polarized era, especially for a woman of color in power who identifies as black. The "angry black woman" trope hovers over all sisters of African descent. Harris is attacked for her laugh. She runs the risk of being perceived as too loud, too forceful, not knowing her place, not staying in her lane, and being arrogant, albeit she is the V.P.

Must Harris struggle to avoid the misogynoir trope when asserting her power and authority? She mustn't be

a titular head for fear of being perceived as unqualified, tokenized, or a DEI hire. Research shows that Harris is one of the most targeted politicians on the Internet, and FOX News runs a constant thread of bogus articles about her.

Job performance

Harris struggled to carve out a lane for herself in her early years, feeling the weight of being the first Black and Asian American V.P. With a job performance approval rating no higher than 39 percent from multiple polls, she had to convince the American public for a second term.

Republicans have made Harris the face of Biden's unfavorable immigration policy to win political ground in this election period. The intersexuality of her race and gender was weaponized to discredit her ability. It was unsurprising to women and people of color that Harris was appointed to fix immigration that previous administrations couldn't resolve, which set her up to fail.

I'm with her!

Harris's blunders were magnified, and her victories muted. Harris has accomplished a lot since taking office. Alongside Biden, Harris helped America get vaccinated, rebuild the economy due to COVID, led Congress to protect voter's rights by building a broad and diverse coalition, expand workers' rights to organize and collectively bargain, and women's issues-reproductive justice since the overturn of Roe v Wade, maternal health, child poverty.

In her first public speech since her running announcement, Harris said, "Building up the middle class will be a defining goal of my presidency. We here know when our middle class is strong, America is strong."

In one day, Harris garnered more than half the delegates needed to win the nomination. She has reenergized the base and injected hope, focusing on working folks like me.

actually America's first gay president. Mary Lincoln's many family losses seem to mitigate the frequent claim about her being mad. Duncan movingly delivers a "Blue and Gray Blues" song connected with Ulysses Grant and the Civil War.

Gage Baker's effective sound design joins with a haunting projection of the atomic bombs dropped on Hiroshima and Nagasaki at the order of Harry Truman. Kontzamanys brings poetry to a modern movement sequence as professionally trained dancer Betty Ford is recalled as a supporter of the Equal Rights Amendment (as yet not fully ratified) and abortion rights. Book-loving Laura Bush is taken to task for standing by as husband George and fellow Republicans were working to dismantle school systems.

Where will future first ladies focus their talents and attention? Will some continue the push for universal health care or for student debt forgiveness? Will others concentrate on LGBT rights? Will a woman president counsel a first gentleman to carry the torch of such activism? "46 Plays for America's First Ladies" pays tribute to some and takes exception to others. Even so, this worthy effort suggests that activism for the American experiment should be the work of us all. Hub Theatre Company's exuberant premiere should inspire all Americans.

Clinton noted, "The First Lady role is really difficult...You have to create it for yourself."

Notwithstanding such definition challenges, five playwrights—Genevieve Gallo-Baylantes, Sharon Greene, Chloe Johnston, Bilal Dardai and Andy Baylantes—have put together short pieces stretching from Martha Washington to Jill Biden in an appropriately titled effort: "46 Plays for America's First Ladies." By turns disturbing, touching, informative and humorous, this often insightful 2020 collaboration (by authors known as Neo-Futurists) has as much to say about the admittedly imperfect American experiment as it does about the very different First Ladies themselves. Hub Theatre Company of Boston—in a vivid and energetic area premiere—is bringing timely attention to White House women at a time when democracy and women's rights are very much at stake.

"46 Plays" calls for versatile actresses and an inventive design team—both of which Hub Theatre brings together under the sharp guidance of director-choreographer Ilyse

Robbins in the intimate performance room at Club Café (where the 12 year old company presents a staging each summer). The multi-talented cast—Yasmeen Duncan, Lauren Elias, Eleni Kontzamanys, Sophia Muharram and Katie Pickett—smoothly portray the 46 and occasionally gender-bend as some of the presidents. The quintet—especially Duncan and Pickett—sing vibrantly on solo, duo and ensemble as well as in rich harmony under the strong music direction of Jack Cline.

Kudos goes to Emily Bearce for very effective strobe lighting and Katie Chen's inspired A.I. E. Rosser ranges from patriotic and informal to parodic and casual in her costume design, and Justin Lahue brings the right ambience and period evocations to his sets. Also look for smart puppet complement from double threat Rosser and Samantha Mastrati—with gifted actor Brooks Reeves as puppet captain (though the Hillary one is rather unflattering, and her work as Secretary of State is not mentioned).

Do not let the lighter elements of "46 Ladies" fool you. There are revealing details about 10 slave-owning early first ladies. Some first ladies confront brutal treatment of Native Americans. The fact that bachelor James Buchanan lived with his male best friend for 10 years—here in gender-bending evocation—is seen as evidence that he was

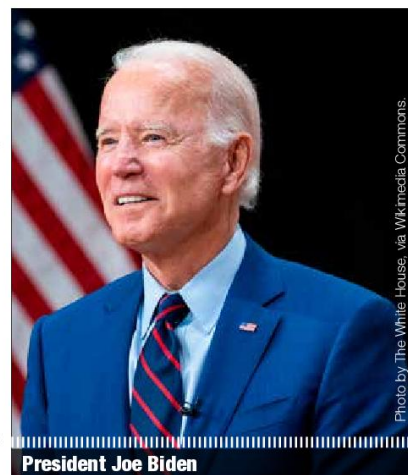

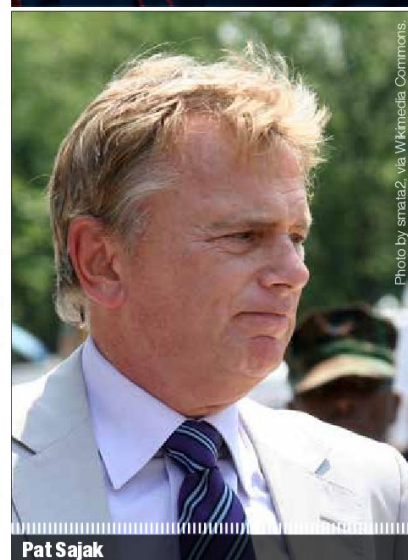

pand to serve the entire LGBTQ community.

Their own path to parenthood in the late aughts was “complicated and confusing,” with “scant resources available,” Rosenberg said. After some twists and turns, they had a son via adoption and twin girls via surrogacy, but Rosenberg reflected, “I don’t think that there is a single decision we made, either in surrogacy or during our adoption journey, where we felt really confident about that decision.”

Rosenberg noted that he is the girls’ genetic parent, which is “really no one else’s business,” but that he mentions “because I’m also HIV positive. I have been since before I met my husband, and we’re about to celebrate our 31st anniversary,” Rosenberg explained, “I want to make sure people know if they’re HIV positive, it doesn’t stop them from being able to become dads through adoption, foster care, or surrogacy and IVF.”

As new dads, they knew they stood out. “We had three little babies, one of them is Black; we had a chihuahua; and we’re two men,” Rosenberg related. “Wherever we went—and I’m not exaggerating—it was like the circus sideshow.” Straight people would ask intrusive questions, and “we were constantly having to explain our stories.” Rosenberg longed to hang out with other gay dads where he wouldn’t feel so “other,” and to share learnings from their own parenthood journey. He couldn’t find the community he sought, however.

Fast forward to 2014, when their oldest was in preschool, and the twins were out of diapers. “Let’s launch something for all gay dads and dads-to-be,” proposed Rosenberg, whose background was in sales and marketing. Gays With Kids (gayswithkids.com) was born.

Initially, the site focused on sharing queer dads’ stories. “We did a lot to give visibility to our families. I know we helped change hearts and minds,” he said.

About three years ago, however, one of the site’s readers reached out to thank Rosenberg “for inspiring me to become a dad.”

Rosenberg was touched, and asked, “What are you going to do now that you’re inspired?”

The man responded, “I have no idea. I guess I’ll just have to wing it.”

“I had an aha moment,” Rosenberg said. While visibility and inspiration were important, he realized they weren’t enough. Instead, he said, “I really wanted to provide a tangible and valuable service.”

That led to the 2022 launch of GWK Academy (gwacad-

emy.com), which offers community, education, and resources, including online courses and coaching, for gay and queer men considering parenthood. Before the end of 2024, Rosenberg said, his goal is “to expand our content and our focus to include everyone under the LGBTQ+ umbrella.”

The site also just became free to join, and Rosenberg hopes that gay and queer men—and soon any LGBTQ+ person—will use it as a first stop to “get educated” if they are thinking about parenthood. Topics covered include the various paths available, costs, timeframes, types of organizations people will need to work with, which ones are LGBTQ+ competent, and more. “They say it takes a village to raise a child,” he said. “The truth of the matter is, for us those in the LGBTQ+ community, it also takes a village to create a child.”

After getting educated, he said, people will be able to have more productive conversations with clinics, agencies, and other family-building organizations. The problem today, however, is not the lack of such organizations, but the sheer number of them. “A lot of people find it overwhelming,” he observed, noting that part of GWK Academy’s value is “to help them get through all the clutter.” It therefore works with an “exclusive network of surrogacy and IVF family building partners,” whom Rosenberg ensures are “as passionate as I am about LGBTQ+ family building.” Referrals to those partners comprise GWK Academy’s revenue stream. While site members can work with any agency or clinic they choose, he said, “I know that ours will take good care of you.”

The site also partners with organizations dedicated to foster care and adoption (but earns no fees from them), and Rosenberg is eager to encourage more gay and queer men to consider becoming foster parents and adopting from foster care. He also makes sure GWK Academy’s programming talks specifically about LGBTQ+ youth in the foster care system, asserting, “I feel like we have some kind of moral obligation as the adults within the community to make sure our young ones are taken care of properly.”

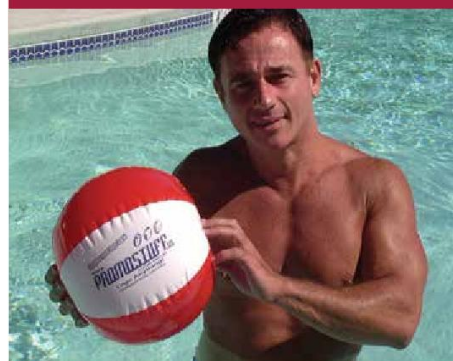
He is in turn inspired by the next generation. “What I love, love, love today,” he said, is that all of the dozens of young gay men he has spoken with in recent years “knew they would have to think about whether they wanted to become parents.” For almost all of them, the answer was yes. “They just weren’t sure yet when or how,” he said. “Sometimes I would cry because it wasn’t an option for us. To see how much things have changed in that respect is so powerful for me.”
